CIRCULAR

Sub:-Applicability of Rajasthan Civil Services (Revised Pay) Rules, 2017 to persons re-employed in Government service after retirement.

Persons re-employed in Government service after retirement have been excluded from the purview of the Rajasthan Civil Services (Revised Pay) Rules, 2017 vide Rule 2(ii)(d) thereof. The question of extension of the benefit of the revised pay rules to these persons and the procedure to be followed for fixing their pay in the revised pay has been under consideration of the Government.

- 2. Accordingly, the matter has been considered and it has been decided that fixation of pay on re-employment of Government servants who retired while drawing pay in the existing Running Pay Band and Grade Pay but re-employed on or after 01.01.2016 in a pay level shall be made with reference to the method of fixation of pay laid down in Rule 11 of Rajasthan Civil Services (Revised Pay) Rules, 2017 and only thereafter pay shall be fixed in accordance with the provisions contained in Rule 152 of the Chapter X of Rajasthan Civil Services (Pension) Rules, 1996. Existing basic pay for this purpose shall mean pay last drawn prior to 01-01-2016.
- 3. The allowances and other facilities shall be admissible on the lines of Finance Department Notification No. F.12(6)FD/Rules/2009 dated 22.09.2014.
- **4. Non accrual of arrears:** Notwithstanding anything contained in this Memorandum, no arrear of pay and allowances thereon, on any account, shall accrue to a re-employed Government servant during the period from 01.01.2016 to 31.12.2016.
